

# Terms and Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who create and submit a video at the URL [www.imuna.org/UNDayContest](http://www.imuna.org/UNDayContest) and are 18 years of age or older as of the date of entry. The Campaign is only open to legal residents of any country and is void where prohibited by law. Employees and volunteers of the International Model United Nations Association, Inc. (hereafter “IMUNA”), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of IMUNA as final and binding as it relates to the content of this Campaign.

3. Campaign Period: Entries will be accepted online starting on September 4th, 12:01 AM, Eastern Daylight Time and ending October 15th, 11:59PM, Eastern Daylight Time.

4. How to Enter: The Campaign must be entered by sending an original video submission to the URL [www.imuna.org/UNDayContest](http://www.imuna.org/UNDayContest). The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Submissions must be less than 1GB in size and less than 5 minutes in length. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of IMUNA. Only one entry from each school will be accepted. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the IMUNA. All submissions become the sole property of IMUNA at the time of their submission.

5. Prizes: The Winner(s) of the Campaign (the “Winner”) will receive a discount on their final registration fees for the National High School Model United Nations Conference 2018 equal to five (5) delegate fees (estimated value of \$525) unless fewer than 5 delegates are registered, in which case the discount will be equal to the delegate fee charge for the number of delegates registered. Actual/appraised value may differ at time of prize award. This discount may not be applied to the initial deposit requested by IMUNA. The specifics of the prize shall be solely determined by the IMUNA. No cash or other prize substitution shall be permitted except at IMUNA’s discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for IMUNA to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected solely by the Executive Director of IMUNA under the supervision of the IMUNA Board of Directors. Winner will be notified by email within five (5) days following selection of Winner. IMUNA shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 14 days from the time award notification was sent, or fails to timely return a completed and executed declaration

and release as required, the prize may be forfeited. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER (AT IMUNA'S SOLE DISCRETION) WILL RESULT IN WINNER'S DISQUALIFICATION AS WINNER OF THE CAMPAIGN, AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

Rights Granted by You: By entering this content (e.g., photo, video, text, etc.), You understand and agree that IMUNA, anyone acting on behalf of IMUNA, and IMUNA's licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the World, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the Campaign, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes. without any further compensation, notice, review, or consent. By entering this content, You represent and warrant that your entry is an original work of authorship, and does not violate any third party's proprietary or intellectual property rights. If your entry infringes upon the intellectual property right of another, You will be disqualified at the sole discretion of IMUNA. If the content of your entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. You shall indemnify, defend, and hold harmless IMUNA from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which IMUNA may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.

9. Terms & Conditions: IMUNA reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond IMUNA's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, IMUNA may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by IMUNA. IMUNA reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. IMUNA has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Campaign may be a violation of criminal and civil laws. Should such attempt be made, IMUNA reserves the right to seek damages to the fullest extent permitted by law.

Limitation of Liability: By entering, You agree to release and hold harmless IMUNA and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the Campaign and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error in the administration of the Promotion or the processing of entries.
